PETITION OF ROAD PAVING FOR WINCHESTER DRIVE IN ORANGEVILLE TOWNSHIP, BARRY COUNTY, MICHIGAN

We the undersigned, representing the record owners of more than fifty (50%) percent of the frontage (or of the total land area) within the district, hereby petition the Orangeville Township Board to CONSTRUCT OR INSTALL ROAD IMPROVEMENTS, (PAVING) OF SAID ROAD, IN THE WINCHESTER DRIVE SECTION OF THE CHATEAU PARK #2 DISTRICT INCLUDING LOTS 26 & 27 OF CHATEAU PARK BY WINCHESTER DRIVE.

We the petitioners, understand that the improvement shall be conducted in accordance with plans for the same to be prepared, reviewed, and approved by the Township Board, and that the cost thereof, including expenses connected with the engineering and legal costs will be assessed against each parcel of land within the proposed district with frontage on Winchester that may benefit from this improvement, and may be divided into equal annual installments for a period to be determined by the Township Board.
