**Motion Trustee Perino to roll back salary and hourly wages of all township employees to the 2019-2020 payroll amounts. Support Clerk Risner, roll call vote: Perino-yes, Ribble-yes, Risner-yes, Ritchie-yes, Rook-yes. Supervisor declared motion carried.**

**Motion Clerk Risner to approve Resolutions 052020 and 052020-1 as presented, regarding Absentee Voter Counting Boards. Support Trustee Ribble, roll call vote: Perino-yes, Ribble-yes, Risner-yes, Ritchie-yes, Rook-yes. Supervisor declared Resolutions adopted.**
