JUNE 4, 2024

Meeting called to order 7 pm. All board members present, Fire Chief Ribble and 14 guest.

Pledge of Allegiance

Motion Trustee Ribble to amend May 14<sup>th</sup> meeting minutes. No support, motion failed.

Motion Treasurer Ritchie to approve May 14<sup>th</sup> meeting minutes as written. Support Trustee Kraai, ayes; Risner, Rook, Kraai, Ritchie; nays; Ribble. Supervisor declared motion carried.

Treasurer's Report:

Motion Clerk Risner to pay \$29,935.22 and any other bills forthcoming in the month of June. Support Trustee Kraai, all ayes, motion carried.

Request for a town hall to meet candidates running for township board positions.

Discussion regarding STR's; Clerk Risner stated Planning and Zoning will have guidance rules by end of the year when master plan is completed. Under proposed rules, Township will collect applications and permit fee before turning application to zoning for approval or denial.

Fire Dept Report:

Chief Ribble distributed both May & June report to the board.
