### Please take notice that the following proposal will appear on the ballot: Delton Kellogg Schools Bond Proposal:

Shall Delton Kellogg Schools, Barry and Allegan Counties, Michigan, borrow the sum of not to exceed Forty-Three Million Dollars (\$43,000,000) and issue its general obligation unlimited tax bonds therefor, in one or more series, for the purpose of:

erecting additions to, remodeling, including security improvements to, furnishing and refurnishing, and equipping and re-equipping school buildings; erecting school support, agricultural science, and outdoor learning facilities; purchasing school buses; and equipping, developing, and improving playgrounds, athletic facilities, and sites?

The following is for informational purposes only:

The estimated millage that will be levied for the proposed bonds in 2025 is .46 mill (\$0.46 on each\$1,000 of taxable valuation) for a 0 mill net increase over the prior year's levy. The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is nineteen (19) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 2.99 mills (\$2.99 on each \$1,000 of taxable valuation).

(Pursuant to State law, expenditure of bond proceeds must be audited and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)
